#### COMPATIBILITY

The compatibility of Stalk Stryke with other products may vary. Always jar test new combinations for compatibility prior to field mixing. Not compatible with combination products that are at a pH of 9.5 or higher.

#### **DIRECTIONS FOR USE**

Stalk Stryke can be used on all soil types and crop residues. Application Timing: Apply post-harvest or pre-emergence on any crop residue at any time during cropping season. Can be applied with burndown herbicides for accelerated cover crop breakdown. Application Methods: Stalk Stryke can be applied broadcast, banded, or through a pivot irrigation system.

**Tank Mix Compatible:** Stalk Stryke can be tank-mixed with liquid fertilizers, herbicides, fungicides, insecticides, or other soil amendment products.

**For Best Results:** Apply Stalk Stryke at a minimum of 0.2 oz per acre. Apply with an adjuvant (sticker) and a carbon-based food source such as amino acid, fulvic acid, seaweed extract. Always fill tank 1/2 full of water and agitate well prior to adding products. Apply minimum of 10 gallons per acre. Residue mositure optimizes performance.
